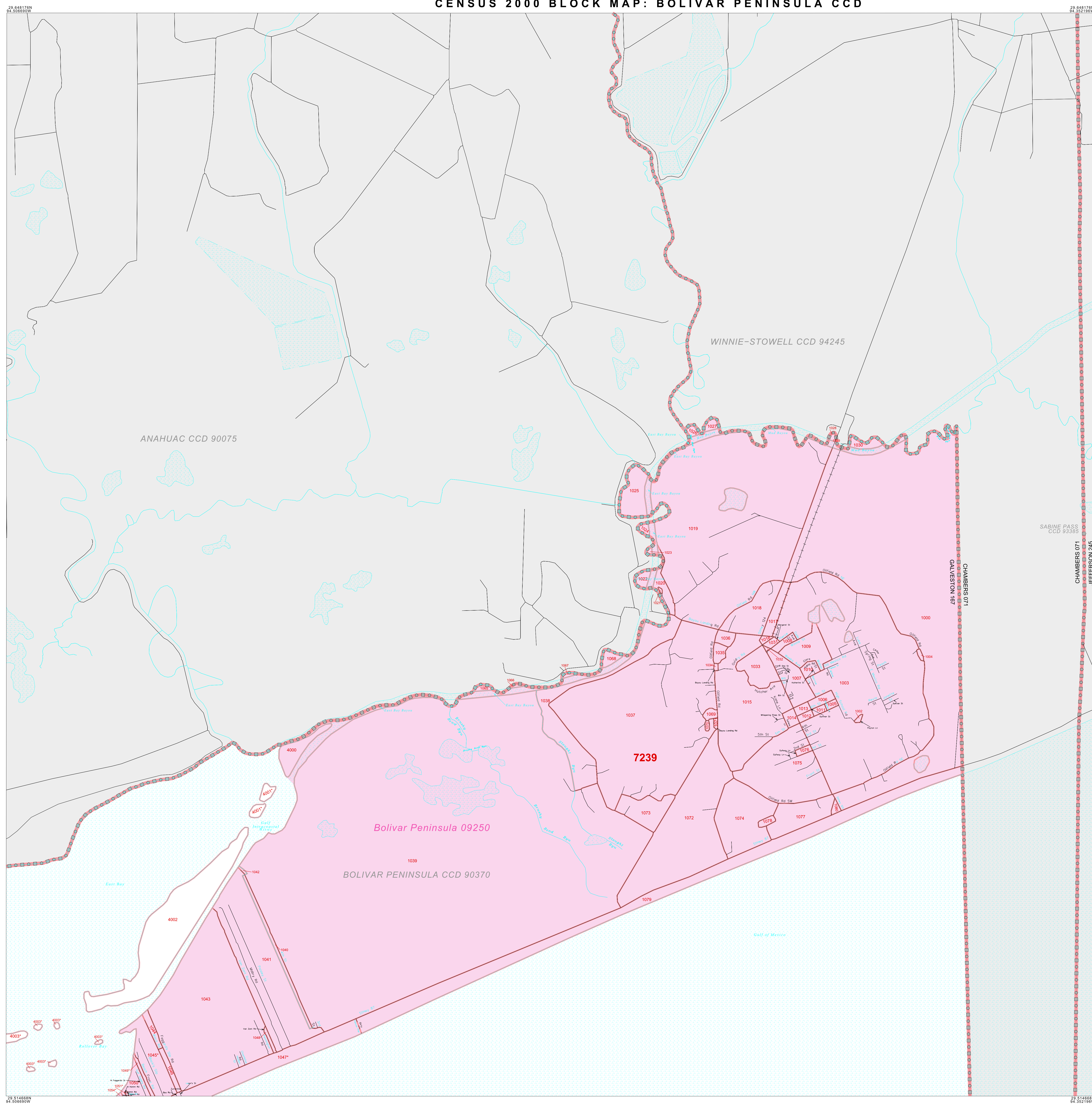


CENSUS 2000 BLOCK MAP: BOLIVAR PENINSULA CCD
